- 6. Injuries received from exposure to the sun, lighting, wind, weather, and elements
- 7. The absence of rapid medical attention/emergency response

We understand the risks, hazards, and dangers of fishing and have had the opportunity to discuss them with a representative of EJS Charters Inc. I, and my party understand that these activities may require good physical conditioning and a degree of skill and knowledge. We believe that we have the good physical conditioning and the degree of skill and knowledge necessary for us to engage in these activities safely.
